On or about February 14, 2020 the Redevelopment Authority County of Fayette, PA (RACF) on behalf of the County of Fayette will submit a request to the Department of Community and Economic Development (DCED) for the release of Community Development Block Grant (CDBG) funds under Title I of the Housing and Community Development Act of 1974, to undertake the following project/s:

FY2015-2016 & 2018-2019- Road Reconstruction – Old Route 51, Menallen Township - Fayette County, Pennsylvania:

Menallen Township will utilize a portion of its FY2015-2016 and its FY2018-2019 CDBG funds to reconstruct Old Route 51 in the Township. The roadway is in extremely deteriorated condition, creating hazardous driving conditions for area residents. The Township will use CDBG funds to place a leveling course of asphalt and overlay the surface with 2" wearing course. The project will reconstruct a total of approximately 4,600 LF of roadway.

As part of the project, the Township will use local resources to replace broken and clogged drainage pipes prior to CDBG funds being invested.

Future similar actions involving road reconstruction whereas the road or a portion of roadway is located in a predicted floodplain and/or wetland area located throughout Fayette County including the entitlement townships of Bullskin, Dunbar, Georges, German, Luzerne, Menallen, North Union, Redstone, and South Union Townships.

ENVIRONMENTAL CERTIFICATION

RACF on behalf of the County of Fayette, PA certifies to DCED that Andrew P. French, in his official capacity as Executive Director consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. DCED's approval of this certification satisfies its responsibilities under NEPA and related laws and authorities and allows the County of Fayette, PA and RACF to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

DCED will accept objections to its release of fund and RACF's certification on behalf of the County of Fayette, PA for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the RACF on behalf of the County of Fayette, PA; (b) RACF on behalf of the County of Fayette, PA has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by DCED; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.

Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the Department of Community and Economic Development, Center for Community Building, 4th Floor, Commonwealth Keystone Building, Harrisburg, Pennsylvania 17120-0225. Potential objectors should contact DCED to verify the actual last day of the objection period.
