- 5. Consider award of a contract for the South Liberty Street, Water System Improvement (Replacement) Project in the Borough of Masontown, Fayette County, Pennsylvania. John T. Subrick, Inc. of Eighty Four, Pennsylvania submitted the lowest acceptable bid amount of \$40,922.00. There were a total of 7 bidders. Authority staff and Sleighter Engineering, Inc. have reviewed the bids and recommend awarding of the contract to John T. Subrick, Inc.
