

**FINAL NOTICE AND PUBLIC EXPLANATION OF PROPOSED ACTIVITIES
IN 100-YEAR/500-YEAR FLOODPLAINS AND/OR WETLANDS**

TO: ALL INTERESTED AGENCIES, GROUPS AND INDIVIDUALS:

This is to give notice that Fayette County, PA has conducted evaluations as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Wetlands Protection. The activities are funded under FY2024-2028 CDBG Programs (Contract Numbers: C000093669 and TBD). Proposed project(s) are located in the Short St Area of Dunbar Boro, along Valley School Road in Nicholson TWP and Mudd School Rd in Bullskin TWP, in the Gates Area of German TWP, and at locations to be determined for similar future projects throughout Fayette County, PA.

The proposed actions involve street improvements and road reconstruction with or without storm improvements along existing roadways as follows: 1) Street Improvements for wall collapse in the Short St Area of Dunbar Boro with approximately 117 LF in a floodplain (Zone AE), 2) Road Reconstruction along Valley School Rd in Nicholson TWP with approximately 121 LF in a floodplain (Zone AE), 3) Road Reconstruction along Mudd School Rd in Bullskin TWP with 1,056 LF in a wetland, and 4) Road Reconstruction in the Gates Area of German TWP with approximately 58 LF in a floodplain (Zone A). Fayette County also reviewed future similar actions involving street improvements and/or road reconstruction whereas the road or a portion of roadway is located in a predicted floodplain and/or wetland area located throughout Fayette County for their effect on passage of floodwaters, alternatives to floodplain development, and for consistency with federal, state, and local policies and regulations on floodplain management. The total number of linear feet and type of floodplain/wetland area for future projects is yet to be determined.

Fayette County, PA has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values: relocation and/or revision of the activity and no action were considered; however, it was determined that neither of these options would provide the same benefit as the activities involve improvements of existing roads.

Fayette County, PA has re-evaluated the alternatives to undertaking this activity in floodplains and/or wetlands and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of Executive Order 11988 and/or 11990, are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and/or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplains and/or wetlands can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains/wetlands, it must inform those who may be put at greater or continued risk.
